Lucy Shires - NNDC - informed that there had been no update from the NNDC Planning Team on the matters she had raised; the response would be forwarded when received. The NNDC budget is suffering with increasing costs including salaries. Long term projects have been put on hold except those which are already programmed. A dedicated website page has been created for electoral services. Customer Service calls have been increased by 33% with residents seeking support and help. Teams have now been set up to deal with issues relating to foodbank vouchers, cost of living grants and members can assist with the completion of forms. There is a facility to leave messages and return calls. A "chat port" is being investigated which will give people direct links to the website. The Youth Council are seeking new members aged 11-18 and an event is being held on the last Sunday of January. Their priorities are Education, Mental Health and Environmental Issues.

Members discussed the issues surrounding Rainbows End and that the units should not be utilised as a permanent address. The use is for holiday use only. This led onto the condition of Mill Lane which was unsuitable for heavy use; there were very deep and wide holes along the access road. These caused residents major problems and would also create problems to the emergency services. Both these matters would be reported and discussed with Planning and Enforcement by Lucy Shires and responded back to the Council.

The Clerk would also write to Rainbows End to remind and alert them to the issues along Mill Lane.

A member of the public spoke about their need for assistance after a fire at the rear of their property. The Council confirmed that they were unfortunately able to offer any financial help however, access would be allowed as required for any remedial repairs.

The Clerk would ask the caretaker to clear the foliage at the rear of the Pavilion area again when the better weather arrived.
